On exam day, you will need to bring a valid international travel passport.

A valid international travel passport:

- Is issued by a national government which certifies, for the purpose of international travel, the identity and nationality of its holder;
 - Passport cards, national identification cards, limited travel documents, internal passports, and passports that are clipped, hole-punched, or marked cancelled are not valid forms of identification for the CFA Program. Learn more
- · Is an original document (photocopies are not allowed) and is current (not expired);
- Contains your name, date of birth, passport number, expiration date, and the name of the country that issued the passport;
- Is machine readable (handwritten passports will not be accepted); and
- Includes a recognizable photograph on the passport data page.

Please note: CFA Institute does not validate the passport data provided to us. It is your responsibility to ensure that you submit valid information from a valid form of identification.

Professional work experience does not have to be investment-related. Part-time positions do not qualify.






